Vision and Objectives of PICOS

With the emergence of services for professional and private online collaboration via the Internet, many European citizens spend work and leisure time in online communities. Users consciously leave private information; they may also leave personalized traces they are unaware of. The objective of the project is to advance the state of the art in technologies that provide privacy-enhanced identity and trust management features within complex community-supporting services that are built on Next Generation Networks and delivered by multiple communication service providers. The approach taken by the project is to research, develop, build, trial and evaluate an open, privacy-respecting, trust-enabling platform that supports the provision of community services by mobile communication service providers.

PICOS results

1 Introduction

The PICOS Website (www.picos-project.eu) is one of the key elements within the project, regarding the provision of information about the project. This counts not only for the internal project work, supported by the internal website, as described in Deliverable D.1.1 „Internal Website“, but also for the public representation of PICOS. To ensure this representation, the public website was developed (launched on february, 25th 2008). The focus of the website is mainly on “information”, wherefore it provides background information about the project and its participants, about ongoing work and results (e.g. deliverables, presentations), as well as dissemination activities (e.g. publications).

It was the main goal, to publish information about PICOS and about trust, privacy and identity management considerations for communities. Furthger, a contact point for the interested public and for the press as well should be established, which also informs about dates of PICOS related activities.

2 Structure and Features

The public Website is structured in 9 different content categories, which are described in the following paragraphs. Additionally, the site contains a content search, a sitemap, which gives an overview of the site structure, and a privacy policy, which describes aspects of privacy regarding the PICOS public website (e.g. how information is collected and used).

The website layout is divided mainly into 3 columns, the left for a sub menu of the horizontal main menu, the middle for content and the right one optional for additional information (where applicable).

2.1 *Home*

Serves as the main entry point to the site. Besides an introductory statement about the background, participants and mission of PICOS, functionalities to search the site content, access to sitemap and privacy policy are provided. On the right side, the latest news items are shown (see 2.2).

2.2 *News*

Provides news information about the project. This comprises information e.g. about achieved results or publications and conference presentations. This allows interested users, to quickly get information about the latest developments in PICOS and its activities.

2.3 *About*

Provides background information about the project. Including details about the underlying motivations, the covered topics and goals of the project.

2.4 *Partners*

A list of all partners participating in PICOS. A separate site is available for each partner, where the partner is described, including his activities and backgrounds.

2.5 *Events*

The section includes dates for important PICOS related public events. This can be e.g. research conferences or workshops, where PICOS or its achievements are presented or where PICOS related topics are covered.

2.6 Resources

Provides access to PICOS downloads, organised in the sub-sections “Public Deliverables”, “Publications” and “Posters & Presentations”. “Public Deliverables” includes all deliverables, which have been finished by PICOS so far and which are available for public access. “Publications” includes articles and papers which were published in the context of PICOS. This includes contributions to scientific conferences and journals. The “Posters & Presentations” sub-section includes according material, which was used to represent PICOS on several occasions (e.g. fact sheet, conference posters).

2.7 Press

Contains collected press publication about PICOS. This includes newspaper articles, as well as internet publications on news sites.

2.8 Links

Contains an overview of links, which are related to PICOS or relevant for the project work. The “Links” section also provides a list of all related projects, to which liaisons or cooperations have been established.

2.9 Contact

This category shows, contact information about PICOS, including physical and e-mail address, as well as a contact form, to get in touch with the PICOS project.

3 Realisation

The PICOS public website is built on the open source web content management system (CMS) TYPO3, as described in Deliverable D.1.1 „Internal Website“. The CMS allows to flexibly extend the functionality of the website, using specific plug-ins (“extensions”) which provide certain functionalities. This helps to continuously adapt the site to its users needs. Within the first project year, the site was extended with a variety of new content (final deliverables, dates, news, press articles, links, presentations, etc.) and features were added and improved (Press section, list of cooperations and liaisons).

However, within the development of the Website there were also some difficulties encountered, which based mainly on technical limitations of the used TYPO3 platform. Even though the platform fulfils a lot of the required functionalities for PICOS, not all of them could have been addressed without any problems. For example extensions used for an RSS Feed and the one for internal Uploads, were not

available in technically stable versions right from the beginning. Some other features were not supported by adequate extensions for the TYPO3 System (e.g. a client for mobile devices).

Besides the extensions of the Websites which were integrated, there were a number of maintenance tasks, which had to be done. Such tasks included regular updates of the TYPO3 system, security updates, backups of relevant data and a lot of further tasks and adjustments like the installing and configuration of extensions or error corrections.
